## Release and Waiver

In consideration of enjoying the rights and privileges of membership in the Great Lakes Gliding Corporation ("GLGC"), I hereby accept all responsibilities of membership or as a guest of a member in GLGC and will obey all the by-laws and operating rules and regulations of GLGC. If I am a full member of GLGC, I acknowledge that I may not fly any GLGC equipment unless my account is in good standing and I am not indebted to GLGC. If I am a day member or guest of a member, I acknowledge my rights and privileges will be limited to those stipulated by GLGC as applicable for day members and guests of members, from time to time. I will be responsible for any damages to any aircraft while I am the pilot-in-command, to the extent such damage is not covered by insurance.

The provisions of this Release and Waiver will remain in effect both during my current membership, as well as any renewal, or participation as a guest of a member now or at any time in the future.

I hereby waive against GLGC (which term is deemed to include the Directors, Officers and members of GLGC) and/or the owner of the lands from which GLGC operates (the "Owner") all claims, demands, actions and causes of action arising directly or indirectly out of any injury or disability which I might suffer in any aircraft operated by, sponsored by, or owned by GLGC, a GLGC member or the Owner or any other person, whether that aircraft be in flight or located on or about the property of GLGC and/or the Owner or in any ground activity involving such aircraft.

I further release and indemnify GLGC and/or the Owner from all liability which may arise in respect of any personal injury or property damage suffered while I am a member of GLGC, the guest of a GLGC member or otherwise partaking in GLGC privileges or using facilities of GLGC and/or the Owner. I further agree to indemnify GLGC and/or the Owner from any claim or legal proceeding brought by any person whom I invite onto the Owner's property or to participate in GLGC activities, unless I have each such person sign this form of Release and Waiver. I agree to waive any right of subrogation, to the extent I am not violating any enforceable term of any applicable policy of insurance, which any insurer might have to bring any action in my name against GLGC and/or the Owner where I have sustained any injury, damage or loss which could give me the right to claim against either GLGC and/or the Owner.

I undertake to make no claim against GLGC and/or the Owner and to indemnify GLGC and the Owner when I sign this Release and Waiver on my own behalf or on behalf of a guest or on behalf of a minor, in respect to any loss as aforesaid, whether such personal injury and/or property damage arises by reason of any negligence of any person, regardless of whether that person is the Owner, GLGC or a member or guest of GLGC, or whether such personal injury and/or property damage arises by reason of an accident involving an aircraft, automobile or other property, regardless of whether GLGC and/or the Owner has a legal interest in such aircraft, automobile or other property or whether such personal injury and/or property damage arises from any other cause whatsoever.
